Digital training: AFNOR Certification validates the quality of the engineering of My-Serious-Game

AFNOR Certification awards the first "AFAQ Digital Training Engineering" certificate to the Touraine company My-Serious-Game. A newly created third-party certification which attests to the rigor of the innovative offering proposed.



On January 24*, on the occasion of World Education Day, My-Serious-Game will receive the certificate of a new certification dedicated to digital training. Created by AFNOR Certification, it validates the quality of the methodology deployed and applies to any type of organization that develops digital educational or training products.

From the analysis of needs to the quality approach of the organization that markets training, the "AFAQ Digital Training Engineering" certification scrutinizes all the design stages (identified needs, objectives, technological framework, etc.).), the educational approach, design and evaluation of the training offered. It is complementary to the Qualiopi certification which will be required of all training organizations by 1_{er}January 2021.

My-Serious-Game worked for more than four years on the development of an ecosystem called EdMill, the heart of which is entirely based on certified digital training engineering. From now on, independent training consultants, training organizations, key account training managers and business experts will be able to use the EdMill ecosystem and its integrated consulting engine to manage all of their digital training actions, ensuring they benefit from 'certified engineering.

For Laurent Dahmani, deputy general director of AFNOR Certification, "*This system dedicated to digital training aims to promote learners' confidence in these new methods of acquiring skills and knowledge. It aims to reassure them of the intrinsic quality of the training they will follow. The certification issued requires us to monitor continued compliance with quality criteria, and the reassurance it provides will contribute to the development of My-Serious-Game.* »
